### **BOARD OF FINANCE MEETING**

School Board President, Zachary Smith Howard, called the Board of Finance Meeting to order at 6:31 p.m.

#### ELECTION OF OFFICERS

# **REVIEW OF INVESTMENT REPORT**

Mr. Fred McWhorter II presented the 2022 Annual Investment Summary Report and the Investment Income History. He stated that the Corporation's primary banking institution for 2022 was Teachers Credit Union and we have worked hard to maintain our relationship with them to insure we receive the best possible return on our investments. # **REVIEW OF DUAB FISCAL INDICATORS**

Mr. Fred McWhorter II stated that a few years ago some school corporations in the State got into financial trouble and as a result the Distressed Unit Appeal Board (DUAB) now oversees Indiana school corporations' budgets. He shared that Franklin Township Community School Corporation looks good as our enrollment has steadily increased, our assessed valuation has also increased and we have had a balanced budget six (6) years in a row. Mr. McWhorter invited the Board to visit the DUAB website to get an overview of the financial status of any school corporation in the State of Indiana. (Exhibit No. 23-17)

President Howard commended Mr. McWhorter for negotiating a wonderful interest rate with TCU. Mr. McWhorter replied that we are looking forward to another increase soon. There were no additional questions or comments.

# FRANKLIN TOWNSHIP EDUCATION FOUNDATION REPORT

President Howard conveyed that the next meeting of the Franklin Township Education Foundation is not until January 17<sup>th</sup>, but he did inform everyone that the application deadline for the following scholarships is February 3<sup>rd</sup>: Dr. Elmo B. Carver Memorial Scholarship, Richard H. Crosser Memorial Scholarship, Mae Dilliner Lowes Memorial Scholarship, and Abby Sherwood Memorial Scholarship. He added that the Elisabeth Good Fellowship application goes live on January 30<sup>th</sup> with a deadline of April 3, 2023.

# LEGISLATIVE SESSION REPORT

President Howard reported that the Indiana General Assembly began its long session today and must conclude by midnight on April 29, 2023. He shared that the main objective this session will be to adopt a two-year state budget. President Howard added that the Governor has submitted a proposed budget which includes a 6% increase for schools for the 1<sup>st</sup> year. He noted that another item for discussion will be the elimination of textbook rental fees for all students. President Howard conveyed that he will be providing Legislative updates at the upcoming Board Meetings. There were no questions or comments.

# GRADUATION RATE REPORT

Dr. Chase Huotari stated Franklin Central High School has much to celebrate regarding their graduation rate and how it compares to other schools. He was thrilled to share that FC's graduation rate of 95.58% is the best in comparison to local area high schools and ranks 2<sup>nd</sup> compared to the high schools in the Hoosier Crossroads Conference. Dr. Huotari noted that the percent rates are for non-waiver graduates that meet academic and pathway requirements established by the IDOE. He added that this is a huge celebration for our dedicated staff and hard working students. Mrs. Foulk stated that this wonderful accomplishment definitely deserves a round of applause. President Howard thanked him for the exciting news and added that it is very impressive that we have such a wide variety of pathways to enable our students to be successful. (Exhibit No. 23-11)

Manual), and Policy C525 – Medical Needs at School. He shared that the changes made since the first reading are highlighted on the summary page and recommended approval of the policies. Ms. Downer made a motion to approve the policies. Mrs. Gowan seconded the motion and it passed 5-0. (Exhibit No. 23-13)

Dr. Chase Huotari recommended approval for the FCHS Open Winter Guard to travel to Dayton, Ohio, on April 13-16, 2023 and the FCHS Percussion Symphony to travel to Dayton, Ohio, on April 20-24, 2023 to compete in the Winter Guard International World Championship. Mrs. Gowan made a motion to approve the field trips and Mr. Walker seconded. The motion carried 5-0. (Exhibit No. 23-14)
