She noted that the Agreement has been reviewed by CCHA and is for the hiring of a Speech Language Pathologist Assistant. Mr. Walker made a motion to approve the Agreement and Mrs. Gowan seconded. Ms. Downer stated that she understands that filling the SLP positions has been difficult and asked if this staff member will allow us to fully implement the IEP's for our students. Dr. Kight replied that she was not aware of any student that has not been receiving their documented services. She asked Ms. Downer to forward any such information to her. 
Mrs. Gowan and Ms. Downer also wished everyone a Happy Thanksgiving.
