Enrollment Projections for Franklin Township Community Schools

Final Results

Key Data Inputs to Projections

- **Grade Transition Ratios:** These are the percent change in enrollment when a student cohort ages from one grade to the next (e.g., a 2nd grade enrollment of 727 in 2016 and 3rd grade enrollment of 774 in 2017 yields a transition ratio of 1.065). Transition ratios offer a good estimate of net migration by age.
- Population Projections by Age: The IBRC estimated kindergarten enrollments using annual population projections in the FTCSC area for the 0 to 4 year old age group. These projections for the FTCSC area were based on the IBRCs recently released projections for Marion County and data on the population by age in the FTCSC area from the U.S. Census Bureau.
- Residential Building Information: The IBRC compiled data from the City of Indianapolis on the annual number of single-family residential lots platted for development in each township. The IBRC also surveyed and interviewed each major home builder in the area to help inform assumptions about specific projections scenarios.


FTCSC Projection Scenarios

- **Baseline Scenario:** Based on the average of the grade transition ratios (TR) from the last six years. Kindergarten enrollment is based on the IBRC's standard population projections by age group.
- **Strong Growth Scenario:** Assumes that the stronger residential development seen in the area over the last two years will continue over the next several years. These projections utilize a weighted average for transition ratios over the past four years along with stronger population projections for the area.

Note: The IBRC believes that future enrollment will be within the range established by the Baseline and Strong Growth scenarios. However, given the recent rebound in residential development and the prospects for future development, the IBRC believes that the FTCSC's enrollment over the next ten years will be closer to projections shown with the Strong Growth scenario.

Residential development in the FTCSC area increased significantly in 2016 and 2017. Residential construction in 2018 is on pace to far exceed the levels of the previous two years.


Annual Number of Lots Platted for Development in Franklin Township

Notes:

- The inventory of existing homes for sale in Marion County remains exceptionally low. The Indiana Association of Realtors reports that the "Months Supply of Inventory" in Marion County was 1.6 months in March 2018. This is lower than the of 3.0 months supply for Indiana, which is the lowest mark on record for the state. This scant inventory of existing homes for sale, coupled with continued low mortgage rates, means that demand for new construction should remain strong.
- All home builders interviewed for this analysis report that demand has been very strong for their communities in the FTCSC area. One sales rep termed the market "Crazy!"
- Two major homebuilders reported that their companies already owned land in the FTCSC area for new subdivisions once their current communities in Franklin Township reach capacity.





FTCSC Total Enrollment, 2005-06 to 2027-28




This graphic presents the average annual change in enrollment for different periods over the past 13 years, along with the average annual change for each projection scenario.
