INSTRUCTIONAL TYPE GUIDANCE

	IN-PERSON INSTRUCTION	Instruction that is provided in real-time where the teacher and students are in the same physical space.
	<u>ASYNCHRONOUS</u> VIRTUAL INSTRUCTION	Instruction that is provided at different times and the teacher and students are in different physical spaces.
	<u>SYNCHRONOUS</u> VIRTUAL INSTRUCTION	Instruction that is provided in real-time, but the teacher and students are in different physical spaces.

ASYNCHRONOUS INSTRUCTION OVERVIEW

INDIANA CODE



Per [Indiana Code](#), districts are allowed no more than three (3) days consisting of more than 50% virtual asynchronous instruction and may be considered instructional days that contribute to the 180 day school year.

GENERAL GUIDELINES



- District PD 8:00 a.m.- 12:00 p.m.
- Teacher Office Hours 1:00 p.m.- 3:00 p.m.



- Chromebooks available for checkout at K-3 buildings.



- Assignments are to be posted by 9:00 a.m. to Canvas/Google Classroom
- 15 min of assigned work per class period



- **K-3:** Students are given 5 school days to complete their work.
- **4-12:** Work is due as indicated by the teacher in Canvas/Google Classroom. If, due to extenuating circumstances, your child cannot complete the assignment by the due date, please reach out to your child's teacher.



- **K-12:** Attendance is dependent on completion of assigned asynchronous work per class.

GENERAL GUIDELINES



All buildings will operate on a Synchronous Learning [.schedule](#) for students.



Teachers will provide direct synchronous instruction (further guidance in this document). Be sure to have your Chromebook and charger on hand.



Lesson information will be accessible for students at the beginning of the synchronous learning schedule within Canvas/Google Classroom.



Any live opportunities provided to students will be recorded, or an alternative will be provided within the Canvas/Google Classroom course for students who may need to access it later.



Students are accountable for their work, and grades will be assigned. Assessments will be given, and graded (if applicable)



Practice (work to be completed outside of school hours) can be assigned. The due date of assignments is at the discretion of the classroom teacher.
