8/10 – 9/18	School Visits: HA team will share timeline with teachers and answer questions.
10/20	During Morning PD Time @ CTEC: CogAT training! 1 st , 3 rd and 5 th grade teachers and Counselors are required to attend.
Prior to 10/26	CogAT administration schedules are created and teachers/counselors create their online sessions. *All online sessions should be created at least 24 hours before test administration.
10/23	All (1-6) Parent and Teacher Nominations are DUE to CTEC. *Late nominations must be sent to CTEC ASAP, and will be manually input at the school level.
10/26-11/20	CogAT test administration: All 1st (ppr), 3rd and 5th grade students and nominated students.
