

# Edmentum Orientation for FTCSC Online Learners

Dear FCJH or FCHS Online Parents and Students,

Your child has been assigned to online learning per your request for the first nine weeks (August 3 - October 2, 2020). Each quarter you will receive notification about the process to opt in/out of online learning per prior FTCSC communication.

Our school has purchased a subscription to an online curriculum platform called **Edmentum Courseware**. Edmentum is a research-based online program that mirrors the Indiana State Standards and FTCSC curriculum maps. We are excited about the benefits this program can bring to our students! As a part of our subscription, your student can access Courseware free of charge from anywhere internet access is available. Courseware also has site-wide security features in place to protect your student's personal information. Students will be assigned a school-based facilitator for their classes, who will reach out by the end of our first full week of school to introduce themselves and begin to check in on students and their progress as they work through the courses. At FCJH, students will be assigned in alphabet groupings to facilitators. At FCHS, both an alphabetical and subject-area based facilitator will be matched with each EdMentum student.
